General application guidelines: Individuals may apply for any and all big game seasons;

however, you are only permitted one deer license per year. Therefore, if applying for multiple deer seasons, you must indicate the preference of your season choices. Individuals must be 15 years old or older to be eligible for a hunting license.

Application and license fees: A \$100 non-refundable application fee is required and must accompany **each season choice** line on the application. The application is due by **August 19th, 2016**. The random computer generated drawing will be **August 26th, 2016**.

Successful applicants will be notified by mail and will have until **September 9th, 2016** to pay in full the total amount due. Failure to provide the license fee by **September 9th, 2016** will mean forfeiture of the license. If licenses are forfeited, alternates will be notified by **September 16th, 2016** and have until **September 23rd, 2016** to pay in full the amount. Failure to provide the license fee for alternates by **September 23rd, 2016** will mean forfeiture of the license.

Party applications: Hunters have the option of applying as a 3- person application. Each individual of the party must purchase a separate application but submit the applications together. You must indicate on the application who you are hunting with. Preferences must be the same for party applications. Party applications will be treated as one application in the drawing, with all individuals failing or succeeding together. If one of the party members cannot hunt, but the others can, the hunter will have the option of forfeiting the license or hunting alone. This must be done by **September 9th, 2016**. Successful applicants cannot transfer licenses to another individual.
