Application DEADLINE is July 27th, 2018 (or postmarked by)

General buddy application guidelines: Individuals may apply for a buddy application and a single application; however, each individual is only permitted one deer license per year and each individual is only allowed to appear on one buddy application. Any individual who puts their name on more than one buddy application will only be entered into the drawing once and **WILL NOT** be refunded for any additional application fees. The first 50 licenses will be reserved for buddy applications and will be drawn first. If an individual is drawn through the buddy application, their name will be taken out of the single application drawing. Both individuals will be issued the same season in regards to archery and firearms, they will only be allowed to differ according to residency. Individuals must be 12 years old or older to be eligible for a hunting license. All applicants under the age of 17 must attach a hunter's safety certificate.

Application and license fees: A \$100 non-refundable application fee is required and must accompany each application. The application is due by **July 27th, 2018**. The random computer-generated drawing will be **August 1st, 2018**. Successful applicants will be notified by certified mail and will have until **August 31st, 2018** to pay in full the total amount due. Failure to provide the license fee by **August 31st, 2018** will result in the forfeiture of the license. One must reside within the boundaries of the Cheyenne River Sioux Tribe to be considered a resident. If one applicant is a resident and one is not, please specify accordingly.
