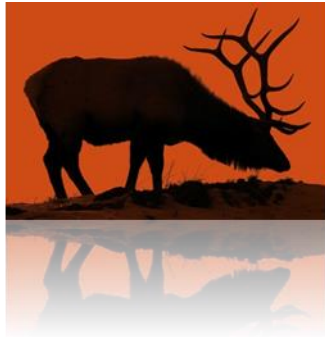


# *Cheyenne River Sioux Tribe*



## *Game, Fish & Parks Department Elk Hunting Information, 2015*

The Cheyenne River Sioux Tribe is pleased to announce that there will be elk hunts available for the 2015 fall hunting season. Both Tribal Members and Non-Tribal Members aged 14 and above are eligible for these hunts. All hunts are management hunts; the CRST GFP decides which animals will be harvested. There will be a total of 40 cows, 20 bulls, and 15 spikes available for harvest.

Hunts will be available on a first come-first serve basis. Hunts will go on sale on September 1<sup>st</sup> at 9:00AM mountain time. Get your hunt this year because there will be no more hunts for the foreseeable future. Full payment will be required when the applications are turned in. Only cashier's checks or money orders will be accepted. Make checks payable to the CRST Game, Fish & Parks Youth Account. Cash can be accepted at the GFP office in Eagle Butte, please do not send cash via mail. Verification of the cashier's check or money order must accompany the application if it is submitted via email or fax (photo copy or picture).
